.Weather Factors You Weren't Taught – And should have been. By Wayne Fink


Aviation text books have not kept pace with improved weather knowledge and forecasting tools. Much of what pilots are taught about weather is a summary

based, in most cases, on a weather manual written over 30 years ago. This seminar fills in some of the blanks with weather facts and insights not covered in most aviation weather sources. New weather terminology has evolved, but is still not mentioned in our texts and manuals, even though it appears in many of our weather sources. Important local weather factors are discussed as well. Most of us have been surprised by unforecast thunderstorms. This seminar gives you new tools to determine the possibility of bad weather, and helps to keep us from being surprised. This presentation qualifies for the FAA Proficient Pilot Award ("Wings") as a safety seminar.

Hicks (T67) to Close for Runway Repair



Are Service Bulletins Mandatory? byTom Ferraro

I recently read an article in "Aircraft Maintenance Technology" that addressed a question that seems to come up often with airplane owners, pilots and mechanics. The title of the article was "Are Service Bulletins Mandatory?" Due to space issues, I will try and recap the major points of this article for our chapter newsletter.

As most airplane owners know, from time to time they receive a mailing from the various airplane manufacturers or component companies in the form of a Service Letter or Service Bulletin. In some cases they are highlighted as "Mandatory or Compliance Required" or words to that effect. The debate begins with professional mechanics and aircraft owners all trying to agree as to whether or not these specific instructions really need to be complied with or not.

So are Service Bulletins or Service Instructions mandatory? It seems that the typical response from most mechanics would be "Yes, if they are referenced or incorporated into an FAA Airworthiness Directive (AD note). That's exactly what I would have said too, until I read this article! It seems that they may be mandatory in some cases even if they are not incorporated into an AD. This statement would seem to be contrary to everything we have ever heard concerning service bulletins. The logic explaining this statement goes like this. Mechanics are required to use the manufacturers maintenance manual or Instructions for Continued Airworthiness when performing maintenance. So, if that maintenance manual or ICA states that compliance with its Service Bulletins and Service Instructions is mandatory, that would make them mandatory regardless of whether or not an AD is issued.

For those of us that may want to continue to debate the details and further discuss what is really intended "between the lines", it seems the NTSB has already weighed in on the topic. In a recent legal ruling, the NTSB concluded "While compliance with Service Instructions or Service Bulletins may not be mandatory in the absence of an AD, a manufacturer may legitimately incorporate service publications into their manual by reference." This specific legal case referenced the Lycoming overhaul manual as the document that published the requirements that all current and future SB's, SI's are an integral part of the overhaul manual.

The bottom line! SB's and SI's are mandatory SOME-TIMES!! The problem is that there is no consistency among aircraft and component manufacturers. Some of the newer companies will continue to insert these requirements into their Instructions for Continued Airworthiness manuals and procedures.

What does this mean for us? Review all SB's and SI's. Determine if they should be complied with. Make sure you or your mechanic use the service manuals with the latest revisions for your airplane. The magazine article summarized this quite nice. "It boils down to common sense. Always follow the manufacturers instructions, whether in the form of maintenance manual, SB's or SI's. They are the experts. They know their products. They are liable for their products. Why would you choose to not follow their recommendations

If you are flying in to TKI, ask ground control for directions to the west MHOA (Mow-a) hangars. They are in the north/west side of the airfield behind the fire station. If you're driving in, turn left just before the fire station, which is the first building on your left as you enter the airport area. Follow the signs to the security gate entrance. We will have gate attendants directing you to designated parking areas. The theme this year is "BE CREATIVE and HAVE FUN"!! Even though you may not consider yourself to be a good Chili cook we want to make this another FUN event so take the plunge and try your hand at cookin' up a big batch of "Red". The more cooks the merrier, so come join in the fun!!

All Chili should be cooked at home and brought to the event. There is electricity for crock pots, but if you have a camp stove, you can bring it to keep your Chili warm. Remember to bring a big serving spoon or ladle too. Be sure to name your Chili, it adds to the FUN part. To add a little mystery you can use a secret ingredient and have people guess what it is!
